LEGISLATURE FOR A RECESS PERIOD TO BEGIN AT THE CLOSE OF
BUSINESS ON AUGUST 1, 2025, AND RECONVENING AT THE OPENING
OF BUSINESS ON SEPTEMBER 8, 2025.”

WHEREAS, under Article II, Section 11, of the Revised Constitution of
American Samoa, each house shall sit upon its own adjournments,
but neither house shall, without the concurrence of the other, adjourn
for more than 3 days; and

WHEREAS, the Legislature, having conducted work on pending matters, and, in
order to preserve legislative session days for most efficient use, it is
appropriate to temporarily recess the business of the Legislature to
fully prepare for disposition of additional and incoming agenda
items.

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE
TERRITORY OF AMERICAN SAMOA, THE HOUSE OF
REPRESENTATIVES CONCURRING:

THAT, the Senate and the House of Representatives shall be adjourned at the
close of business on Friday, August 1, 2025, and reconvene on the opening of
business in each respective chamber on Monday, September 8, 2025.
